Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. Kiowa County is a small rural county in south-central Kansas. Greensburg was heavily rebuilt after 2007 tornado and may have updated zoning regulations. Contact Kiowa County Clerk or City of Greensburg for home occupation permit requirements.

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
