Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. Lane County is one of Kansas's smallest counties by population. Unincorporated areas governed by county zoning. Contact Lane County Clerk for home occupation permit requirements. Agricultural zone dominates; home-based food operations generally permissive.

Upon-complaint. Consumer complaint or illness investigation

Business license

Varies

Pickup / delivery

Direct delivery to consumer permitted in-state

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
