Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. Morton County is a small rural county in the extreme southwestern corner of Kansas near the Oklahoma and Colorado borders. Unincorporated areas governed by county zoning. Contact Morton County Clerk for home occupation permit requirements.

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
