Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. Riley County Planning & Development handles permits for unincorporated county areas (<https://www.rileycountyks.gov/2070/Applications-and-Permits>). City of Manhattan has its own business licensing and zoning for properties within city limits. Home occupation permit likely required for operations within residential zoning districts.

Upon-complaint. Consumer complaint or illness investigation

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
