Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. Sheridan County is a very small rural county in northwestern Kansas. Unincorporated areas governed by county zoning. Contact Sheridan County Clerk for home occupation permit requirements. Agricultural zone dominates.

Pickup / delivery

Direct delivery to consumer permitted in-state

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
