Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

No. Stanton County is a very small rural Kansas county in the southwest corner of the state. No county-specific cottage food ordinance or home occupation permit requirement for cottage food was identified. County seat is Johnson City (no county seat was listed in source data; Johnson City is the known seat). State law does not require registration or permit.

Health

Upon-complaint. No routine inspection; complaint-driven only per state baseline.

Business license

No

Pickup / delivery

Direct sales only. Sales at farmers markets, home pickup, roadside stands, and events permitted. No wholesale or retail indirect sales.

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
