This is what it takes to sell from a home kitchen in Fulton County. Confirm each step with Planning, Health, and the license office before you sell.

What you need

Fulton County, Kentucky. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Kentucky registration: Yes. Routine kitchen inspection: Upon-complaint. Sales limited to direct-to-consumer only within Kentucky — from home (pickup or delivery), markets, roadside stands, community events, and online; shipping outside Kentucky is prohibited, and sales to restaurants or retail stores for resale are not allowed.

Zoning / home occupation

Varies. No county-specific home occupation ordinance identified for Fulton County. State law requires annual \$50 registration with CHFS Food Safety Branch (form DFS-250) before selling. Operators should contact the Fulton County planning/zoning office and county judge-executive to confirm whether a local home occupation permit or business license is also required.

Health

No. Cabinet for Health and Family Services may inspect annually at discretion, or upon complaint/mislabeling report. No routine pre-approval inspection required.

Business license

Varies

Pickup / delivery

Direct-to-consumer only. Permitted venues: home (on-premises pickup), farmers markets, certified roadside stands, community events, fairs, festivals, and personal delivery within Kentucky. Online orders allowed if fulfilled by in-state pickup or personal delivery. No wholesale to restaurants or retail stores. No mail/common-carrier shipping.

If you rent a commissary kitchen

Local health departments permit food service. Kentucky cottage food / home-based processor paths do not replace a food-service permit. A commissary is permitted by the local health department.
