This is what it takes to sell from a home kitchen in Jessamine County. Confirm each step with Planning, Health, and the license office before you sell.

What you need

Jessamine County, Kentucky. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Kentucky registration: Yes. Routine kitchen inspection: Upon-complaint. Sales limited to direct-to-consumer only within Kentucky — from home (pickup or delivery), markets, roadside stands, community events, and online; shipping outside Kentucky is prohibited, and sales to restaurants or retail stores for resale are not allowed.

Zoning / home occupation

Conditional. Jessamine County is a suburban county adjacent to Lexington. Local occupational license may be required in Nicholasville or unincorporated Jessamine County. State registration (\$50/year) required through KY Food Safety Branch. Contact Jessamine County government in Nicholasville.

Health

Upon-complaint. KY Food Safety Branch may inspect on complaint or foodborne illness investigation.

Business license

Varies

Pickup / delivery

Direct sales to consumers only (KRS §217.136). No wholesale or retail store channel.

If you rent a commissary kitchen

Local health departments permit food service. Kentucky cottage food / home-based processor paths do not replace a food-service permit. A commissary is permitted by the local health department.
