Nelson County, Kentucky. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Kentucky registration: Yes. Routine kitchen inspection: Upon-complaint. Sales limited to direct-to-consumer only within Kentucky — from home (pickup or delivery), markets, roadside stands, community events, and online; shipping outside Kentucky is prohibited, and sales to restaurants or retail stores for resale are not allowed.

Zoning / home occupation

Varies. Nelson County has a zoning ordinance (revised November 2024; available from nelsoncountyny.gov). Home occupation provisions are typical for KY counties. Bardstown city limits have separate zoning. No specific cottage food overlay identified in the zoning ordinance title search.

Health

Upon-complaint. Consumer complaint or foodborne illness investigation

Business license

Varies

Pickup / delivery

Direct-to-consumer only within KY; farmers markets, roadside stands, fairs, festivals, community events, online orders (in-state); home pickup and delivery allowed. No wholesale, no mail delivery, no out-of-state.

If you rent a commissary kitchen

Local health departments permit food service. Kentucky cottage food / home-based processor paths do not replace a food-service permit. A commissary is permitted by the local health department.
