Where to file

State

Kentucky registration: Yes. Routine kitchen inspection: Upon-complaint. Sales limited to direct-to-consumer only within Kentucky — from home (pickup or delivery), markets, roadside stands, community events, and online; shipping outside Kentucky is prohibited, and sales to restaurants or retail stores for resale are not allowed.

Varies. No county govt URL provided. Oldham County is a suburban county adjacent to Louisville. Unincorporated areas follow county zoning. City of La Grange has its own zoning. No county-specific cottage food overlay identified.

Upon-complaint. Consumer complaint or foodborne illness investigation

Business license

Pickup / delivery

Direct-to-consumer only; no wholesale; no internet sales to out-of-state

If you rent a commissary kitchen

Local health departments permit food service. Kentucky cottage food / home-based processor paths do not replace a food-service permit. A commissary is permitted by the local health department.
