This is what it takes to sell from a home kitchen in Pike County. Confirm each step with Planning, Health, and the license office before you sell.

What you need

Pike County, Kentucky. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Kentucky registration: Yes. Routine kitchen inspection: Upon-complaint. Sales limited to direct-to-consumer only within Kentucky — from home (pickup or delivery), markets, roadside stands, community events, and online; shipping outside Kentucky is prohibited, and sales to restaurants or retail stores for resale are not allowed.

Zoning / home occupation

Varies. Pike County and City of Pikeville may have home occupation zoning requirements. Operators should check with Pike County Planning and Zoning.

Health

Upon-complaint. Kentucky may inspect upon complaint; registration processed by state, not county.

Business license

Varies

Pickup / delivery

Direct sales only. Farmers markets, home pickup, events permitted. No wholesale, no retail store sales.

If you rent a commissary kitchen

Local health departments permit food service. Kentucky cottage food / home-based processor paths do not replace a food-service permit. A commissary is permitted by the local health department.
