What you need

Warren County, Kentucky. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Kentucky registration: Yes. Routine kitchen inspection: Upon-complaint. Sales limited to direct-to-consumer only within Kentucky — from home (pickup or delivery), markets, roadside stands, community events, and online; shipping outside Kentucky is prohibited, and sales to restaurants or retail stores for resale are not allowed.

Zoning / home occupation

Varies. Warren County zoning ordinance applies in unincorporated areas. City of Bowling Green (home of Western Kentucky University) has its own home occupation ordinance. No specific county-level cottage food override identified.

Health

Upon-complaint. KCHFS may inspect upon complaint.

Business license

Varies

Pickup / delivery

Direct sales only. Sales from home, farmers markets, roadside stands, and events.

If you rent a commissary kitchen

Local health departments permit food service. Kentucky cottage food / home-based processor paths do not replace a food-service permit. A commissary is permitted by the local health department.
