Where to file

State

Louisiana registration: No. Routine kitchen inspection: No. Most low-risk foods may be sold indirectly (to restaurants, retail stores), but breads, cakes, cookies, and pies specifically may NOT be sold to any retail business or individual for resale — they are direct-to-consumer only.

Conditional. Caddo Parish and City of Shreveport may require home occupation permit or business license. No county URLs provided in input. Check with Caddo Parish Planning Department or City of Shreveport Permits.

Some indirect sales allowed for most low-risk foods; baked goods categories have stricter rules. Sales tax certificate required.

If you rent a commissary kitchen

LDH permits retail food. Louisiana cottage food is a home path. A commissary is a retail food establishment permitted by the Louisiana Department of Health.
