Where to file

State

Louisiana registration: No. Routine kitchen inspection: No. Most low-risk foods may be sold indirectly (to restaurants, retail stores), but breads, cakes, cookies, and pies specifically may NOT be sold to any retail business or individual for resale — they are direct-to-consumer only.

Zoning / home occupation

Varies. Ouachita Parish may require a home occupation permit under local zoning. A parish sales tax certificate is required before selling cottage foods in the parish.

Health

No. LDH may act on complaint or suspected foodborne illness.

Business license

Pickup / delivery

Indirect sales of most low-risk foods allowed (except the four named baked goods categories, which must be direct-to-consumer). No geographic restriction noted.

If you rent a commissary kitchen

LDH permits retail food. Louisiana cottage food is a home path. A commissary is a retail food establishment permitted by the Louisiana Department of Health.
