This is what it takes to sell from a home kitchen in Talbot County. Confirm each step with Planning, Health, and the license office before you sell.

What you need

Talbot County, Maryland. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Maryland registration: Depends. Routine kitchen inspection: Upon-complaint. Sales at retail food stores (indirect) are allowed but require prior submission of labels and documentation of ANSI-accredited food safety course completion to the Maryland Department of Health before any retail sales can commence. The Department must notify the producer in writing that requirements are met before retail sales begin.

Zoning / home occupation

Varies. Talbot County (Eastern Shore) requires compliance with all applicable county and municipal laws per Md. Code Health-Gen. §21-330.1(e). Contact Talbot County Department of Planning and Zoning for home occupation requirements. Talbot County is a higher-income Eastern Shore county with active zoning. No county-specific cottage food ordinance identified beyond state mandate.

Health

Upon-complaint. No routine pre-operational inspection required for standard direct-to-consumer sales. MDH may inspect upon complaint.

Business license

Varies

Pickup / delivery

Direct-to-consumer sales permitted. Retail store sales require prior MDH approval.

If you rent a commissary kitchen

MDH and local health license food facilities. Maryland cottage food is not a food-service facility license. A commissary is a food service facility licensed by the local health department.
