Berrien County, Michigan. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Michigan registration: No. Routine kitchen inspection: No. Sales through retail stores, restaurants, or wholesale are prohibited. Online sales, mail order, and third-party delivery platform sales (e.g., DoorDash) are allowed in-state only, but require the producer to offer the customer an opportunity to directly interact (face-to-face or virtually) before purchase. A separate \$75,000 cap applies if all products are priced at \$250 or more per item. Honey and maple syrup have a separate exemption permitting indirect retail sales up to \$15,000/year.

Varies. Berrien County may require a home occupation permit under local zoning. No county-specific cottage food overlay identified.

Health

No. No routine inspection. Complaint-based enforcement by MDARD.

Business license

Pickup / delivery

Direct-to-consumer sales only. No consignment or wholesale. Online and third-party delivery platform sales now allowed with interaction requirement per 2025 amendment.

If you rent a commissary kitchen

Local health departments license food service. Michigan cottage food is an exemption. A commissary is a food service establishment licensed by the local health department.
