Where to file

State

Michigan registration: No. Routine kitchen inspection: No. Sales through retail stores, restaurants, or wholesale are prohibited. Online sales, mail order, and third-party delivery platform sales (e.g., DoorDash) are allowed in-state only, but require the producer to offer the customer an opportunity to directly interact (face-to-face or virtually) before purchase. A separate \$75,000 cap applies if all products are priced at \$250 or more per item. Honey and maple syrup have a separate exemption permitting indirect retail sales up to \$15,000/year.

Varies. Grand Traverse County townships and City of Traverse City may have home occupation zoning requirements. Traverse City is a tourist destination with active farmers markets. Operators should check with Grand Traverse County Planning (231-922-4784) or City of Traverse City for home-based business rules.

Direct sales allowed from home, at farmers markets, at events; online/mail order and third-party delivery allowed per 2025 HB 4122 (effective March 2026) with face-to-face or virtual interaction requirement.

If you rent a commissary kitchen

Local health departments license food service. Michigan cottage food is an exemption. A commissary is a food service establishment licensed by the local health department.
