Where to file

State

Michigan registration: No. Routine kitchen inspection: No. Sales through retail stores, restaurants, or wholesale are prohibited. Online sales, mail order, and third-party delivery platform sales (e.g., DoorDash) are allowed in-state only, but require the producer to offer the customer an opportunity to directly interact (face-to-face or virtually) before purchase. A separate \$75,000 cap applies if all products are priced at \$250 or more per item. Honey and maple syrup have a separate exemption permitting indirect retail sales up to \$15,000/year.

Zoning / home occupation

Conditional. No specific Newaygo County cottage food or home occupation rules found. Individual townships within Newaygo County may have zoning resolutions. Recommend verifying with Newaygo County Planning/Zoning and the relevant township.

Health

No. No license or inspection required for qualifying cottage food operations.

Business license

Pickup / delivery

Direct-to-consumer sales only. Online and mail order allowed per 2025 amendment (MCL §289.4102, effective March 2026). No wholesale or consignment.

If you rent a commissary kitchen

Local health departments license food service. Michigan cottage food is an exemption. A commissary is a food service establishment licensed by the local health department.
