Where to file

State

Michigan registration: No. Routine kitchen inspection: No. Sales through retail stores, restaurants, or wholesale are prohibited. Online sales, mail order, and third-party delivery platform sales (e.g., DoorDash) are allowed in-state only, but require the producer to offer the customer an opportunity to directly interact (face-to-face or virtually) before purchase. A separate \$75,000 cap applies if all products are priced at \$250 or more per item. Honey and maple syrup have a separate exemption permitting indirect retail sales up to \$15,000/year.

Zoning / home occupation

Varies. No state-level permit required. Schoolcraft County is a small, rural Upper Peninsula county; home occupation zoning rules are set at the township level. Operators should contact their specific township zoning administrator in Manistique or surrounding townships.

Health

No. Complaint-based only; MDARD may inspect if foodborne illness or complaint is received.

Business license

Varies

Pickup / delivery

Direct sales, online, mail order, farmers markets, craft shows, roadside stands permitted within Michigan. No wholesale or retail consignment.

If you rent a commissary kitchen

Local health departments license food service. Michigan cottage food is an exemption. A commissary is a food service establishment licensed by the local health department.
