Where to file

State

Minnesota registration: Yes. Routine kitchen inspection: No. Sales are limited to direct-to-consumer channels: community events, farmers markets, from the producer's home, online (in-state delivery by the producer personally or by mail/commercial delivery), and fundraising donations. Restaurants, retail stores, roadside stands, mail order wholesale, and catering are prohibited. All deliveries must be made by the producer personally unless shipped by mail or commercial delivery upon a prior online sale. Home-canned products in the pH/water-activity exemption category (Subd. 1(a)(2)) may not be sold outside of Minnesota.

Zoning / home occupation

Varies. Pennington County may require a home occupation permit under local zoning. No county-specific cottage food overlay identified. Producers should verify with Pennington County and Thief River Falls city planning.

Health

No. No routine inspection. Complaint-based enforcement possible by MDA.

Business license

Varies

Pickup / delivery

Direct sales to consumers in person, at farmers markets, roadside stands, on-farm, community events, online (within MN only). No interstate sales for home-canned category. No third-party retail distribution.

If you rent a commissary kitchen

MDA licenses food; local health may license food service. Minnesota cottage foods is an exemption. A commissary typically needs an MDA food handler license and/or a local food-service license, depending on the kitchen.
