Where to file

State

Mississippi registration: No. Routine kitchen inspection: Upon-complaint. Mississippi prohibits Internet sales, mail order, wholesale, and retail establishment sales. Cottage food products may only be sold through in-person direct-to-consumer channels including events, farmers markets, home sales, and roadside stands. Advertising on the Internet including social media is permitted even though sales through those channels are not.

Zoning / home occupation

Varies. Lee County and the City of Tupelo may have home occupation ordinances. No specific Lee County cottage food ordinance identified. Producers should check with Lee County Planning or City of Tupelo planning/zoning offices.

Health

Upon-complaint. No routine inspection. MSDH may investigate upon complaint or suspected foodborne illness.

Business license

Varies

Pickup / delivery

In-person direct sales only: at home, at events, at farmers markets. No internet, mail order, wholesale, or retail store sales.

If you rent a commissary kitchen

MSDH permits food establishments. Mississippi cottage food is a home path. A commissary is a food establishment permitted by the Mississippi State Department of Health.
