Where to file

State

Missouri registration: No. Routine kitchen inspection: No. Under §196.298, sales must be directly to consumers from the producer's home. Events, farmers markets, restaurants, retail stores, and roadside stands are not permitted under this law. Internet/online sales are allowed but only if both the producer and buyer are located in Missouri. Local health departments are explicitly prohibited from regulating the production of food at cottage food operations. A separate Missouri statute (individual stands law) allows sales at events and roadside stands in counties that have adopted it, permitting most other nonperishable foods.

Zoning / home occupation

Varies. Adair County does not appear to have county-wide zoning. Kirksville (county seat) has its own city zoning; a home occupation permit may be required by the City of Kirksville for running a business from a residential property. No county-specific cottage food overlay identified. Producers should verify with Kirksville city planning.

Health

No. Missouri law expressly bars local health departments from regulating cottage food production (§196.298(3)(1)). No routine inspections. State may investigate foodborne illness complaints.

Business license

Varies

Pickup / delivery

Missouri cottage food law allows direct-to-consumer sales from home, online (in-state shipping as of 2022 amendment), and at events/farmers markets. Home pickup permitted. Delivery to customers allowed. No sales at restaurants or retail stores under §196.298.

If you rent a commissary kitchen

A commissary is a food establishment. Cottage food is not. Missouri cottage food is not a food-service establishment. A rented kitchen is permitted by the local health department or DHSS.
