Where to file

State

Missouri registration: No. Routine kitchen inspection: No. Under §196.298, sales must be directly to consumers from the producer's home. Events, farmers markets, restaurants, retail stores, and roadside stands are not permitted under this law. Internet/online sales are allowed but only if both the producer and buyer are located in Missouri. Local health departments are explicitly prohibited from regulating the production of food at cottage food operations. A separate Missouri statute (individual stands law) allows sales at events and roadside stands in counties that have adopted it, permitting most other nonperishable foods.

Zoning / home occupation

Varies. Camden County does not appear to have county-wide zoning. Camdenton (county seat) and Lake Ozark/Osage Beach (tourist/resort communities) may require home occupation permits under city or township zoning. No county-specific cottage food overlay identified. Producers in resort areas should check local rules carefully.

Health

No. Missouri law expressly bars local health departments from regulating cottage food production (§196.298(3)(1)). No routine inspections.

Business license

Varies

Pickup / delivery

Missouri cottage food law allows direct-to-consumer sales from home, online (in-state shipping as of 2022), and at events/farmers markets. Home pickup permitted. No sales through restaurants or retail stores under §196.298.

If you rent a commissary kitchen

A commissary is a food establishment. Cottage food is not. Missouri cottage food is not a food-service establishment. A rented kitchen is permitted by the local health department or DHSS.
