Where to file

State

Missouri registration: No. Routine kitchen inspection: No. Under §196.298, sales must be directly to consumers from the producer's home. Events, farmers markets, restaurants, retail stores, and roadside stands are not permitted under this law. Internet/online sales are allowed but only if both the producer and buyer are located in Missouri. Local health departments are explicitly prohibited from regulating the production of food at cottage food operations. A separate Missouri statute (individual stands law) allows sales at events and roadside stands in counties that have adopted it, permitting most other nonperishable foods.

Zoning / home occupation

Varies. Lincoln County may have home occupation zoning requirements. Missouri prohibits local health department regulation of cottage food but general land-use zoning may still apply. Operators should check with Lincoln County Planning.

Health

No. Missouri expressly prohibits local health departments from regulating cottage food operations (§196.298(3)(1)).

Business license

Varies

Pickup / delivery

Direct sales to consumers. Home pickup, farmers markets, events permitted. Online/in-state shipping also allowed per 2022 amendment (HB 1697). No wholesale, no restaurant/retail store sales under §196.298.

If you rent a commissary kitchen

A commissary is a food establishment. Cottage food is not. Missouri cottage food is not a food-service establishment. A rented kitchen is permitted by the local health department or DHSS.
