Where to file

State

Missouri registration: No. Routine kitchen inspection: No. Under §196.298, sales must be directly to consumers from the producer's home. Events, farmers markets, restaurants, retail stores, and roadside stands are not permitted under this law. Internet/online sales are allowed but only if both the producer and buyer are located in Missouri. Local health departments are explicitly prohibited from regulating the production of food at cottage food operations. A separate Missouri statute (individual stands law) allows sales at events and roadside stands in counties that have adopted it, permitting most other nonperishable foods.

Zoning / home occupation

Unknown. Stone County has a Planning and Zoning office at 112 E. 5th Street, Galena MO (417-357-8402). Zoning regulations and a Comprehensive Plan exist; however, specific home occupation permit requirements were not identified in available sources. Operators should contact Stone County P&Z directly to confirm requirements.

Health

No. Missouri law expressly bars local health departments from regulating cottage food production (§196.298(3)(1)). No routine inspections. Stone County Health Department maintains separate food ordinance for permitted establishments; cottage foods are exempt.

Pickup / delivery

Missouri cottage food law allows direct-to-consumer sales from home and at events/farmers markets. In-state online sales permitted per 2022 amendment (HB 1697). Home pickup and delivery to customers allowed.

If you rent a commissary kitchen

A commissary is a food establishment. Cottage food is not. Missouri cottage food is not a food-service establishment. A rented kitchen is permitted by the local health department or DHSS.
