Where to file

State

Nebraska registration: Yes. Routine kitchen inspection: No. Sales must be direct-to-consumer. Wholesale to restaurants, grocery stores, or distributors is not permitted under the cottage food framework. Non-TCS foods may be mailed; TCS foods must be delivered in person by the producer within 2 hours.

Zoning / home occupation

Varies. Deuel County is one of Nebraska's smallest counties in the panhandle. Unincorporated areas very likely have no county zoning or minimal regulations. City of Chappell has its own municipal zoning.

Health

No. No routine inspection required; complaint-driven investigation possible

Business license

Pickup / delivery

Direct delivery to consumer permitted in-state; no wholesale to retailers

If you rent a commissary kitchen

Local health or NDA, depending on the kitchen. Nebraska cottage food is a home exemption. A commissary is a food establishment. Ask the kitchen whether the local health department or the Department of Agriculture licenses that facility.
