Where to file

State

Nebraska registration: Yes. Routine kitchen inspection: No. Sales must be direct-to-consumer. Wholesale to restaurants, grocery stores, or distributors is not permitted under the cottage food framework. Non-TCS foods may be mailed; TCS foods must be delivered in person by the producer within 2 hours.

Zoning / home occupation

Varies. Lincoln County is one of Nebraska's larger counties with North Platte as the county seat (a significant regional hub). County zoning for unincorporated areas likely includes home occupation provisions. City of North Platte has its own municipal zoning and may require a home occupation permit for cottage food operations in residential zones.

Direct delivery to consumer permitted in-state; no wholesale to retailers

If you rent a commissary kitchen

Local health or NDA, depending on the kitchen. Nebraska cottage food is a home exemption. A commissary is a food establishment. Ask the kitchen whether the local health department or the Department of Agriculture licenses that facility.
