Where to file

State

New Mexico registration: No. Routine kitchen inspection: No. Sales must be direct to consumers within New Mexico. Products may not be sold to restaurants, wholesalers, distributors, or outside New Mexico. Internet, mail, and phone sales directly to consumers are permitted. The NMED Food Safety Program does not have jurisdiction in Bernalillo County and Albuquerque (which have their own programs); those areas may operate mandatory or voluntary permit systems.

Zoning / home occupation

Varies. Chaves County includes Roswell. No specific county-level home occupation permit for cottage food identified beyond state requirements. Contact Chaves County Planning & Zoning or City of Roswell for local zoning.

Health

No. No routine inspection; NMED may issue written warning before fines (max \$100/violation)

Business license

Varies

Pickup / delivery

Direct sales to consumers via any channel within NM: farmers markets, festivals, internet, roadside stands, home pickup/delivery, mail delivery. No interstate sales. No restaurant or wholesale channel.

If you rent a commissary kitchen

Environment Department licenses food. New Mexico cottage food is a home path. A commissary is a food establishment licensed by the Environment Department or the local environmental health office.
