Where to file

State

North Dakota registration: No. Routine kitchen inspection: No. Transactions must be directly between the cottage food operator and the 'informed end consumer' and solely for home consumption. Products may not be sold or used in any food establishment, food processing plant, or food store. No wholesale channel is permitted.

Zoning / home occupation

Conditional. ND statute (§23-09.5-02(1)) expressly prohibits state agencies and political subdivisions from requiring licensure, permitting, or certification for cottage food. However, local zoning (Fargo municipal code) may require a home occupation permit for any home-based business. Cass County has not been verified to have a specific cottage food ordinance beyond state law. Fargo city allows home-based businesses under home occupation permits with few restrictions.

Health

No. State may investigate complaints related to foodborne illness. No routine inspections.

Business license

Varies

Pickup / delivery

Sales may occur at farm, ranch, farmers market, farm stand, home-based kitchen, or any non-prohibited venue, including delivery. Direct producer-to-consumer transactions only.

If you rent a commissary kitchen

Local health units license food establishments. North Dakota cottage food is a home path. A commissary is a food establishment licensed by the local health unit.
