Where to file

State

Ohio registration: No. Routine kitchen inspection: No. Labeled cottage food products may be sold to or used by retail food establishments and food service operations licensed under Ohio Revised Code Chapter 3717. This enables indirect/wholesale sales within Ohio. Products may not be sold outside the state of Ohio.

Zoning / home occupation

Conditional. Ashland County zoning resolution (Section 604) requires home occupation to be located in main dwelling or attached garage. Max 300 sq ft. Only full-time live-in residents may be employed. No accessory building use. Signs limited to 6 sq ft. Zoning permit may not be required for businesses conducted entirely inside residence with no outside signs and no customer/supplier traffic (per Section 700 exemption). Township-level zoning inspector administers rules.

Health

No. No routine inspection. State/local health authority may inspect only upon complaint or suspected foodborne illness. Direct-from-site sales require no license or inspection.

Business license

Varies

Pickup / delivery

Direct-to-consumer sales from production site permitted without license. Farmers market sales also allowed without separate license. Customer traffic at home may trigger township zoning permit requirement.

If you rent a commissary kitchen

ODA cottage food is not a food-service license. Ohio cottage food may be sold to licensed food-service operations. Baking in a commissary means that kitchen's food-service or food-establishment license applies. Local health departments license food service.
