Where to file

State

Ohio registration: No. Routine kitchen inspection: No. Labeled cottage food products may be sold to or used by retail food establishments and food service operations licensed under Ohio Revised Code Chapter 3717. This enables indirect/wholesale sales within Ohio. Products may not be sold outside the state of Ohio.

Zoning / home occupation

Varies. No state-level permit required. Carroll County zoning resolutions may require a home occupation permit for unincorporated areas. Contact Carroll County Regional Planning Commission in Carrollton for local requirements.

Health

No. ODA has sampling authority; no routine inspection required.

Business license

Varies

Pickup / delivery

Direct sales (home, farmers markets, events) and indirect sales to licensed retail food establishments permitted within Ohio. No out-of-state sales.

If you rent a commissary kitchen

ODA cottage food is not a food-service license. Ohio cottage food may be sold to licensed food-service operations. Baking in a commissary means that kitchen's food-service or food-establishment license applies. Local health departments license food service.
