Where to file

State

Ohio registration: No. Routine kitchen inspection: No. Labeled cottage food products may be sold to or used by retail food establishments and food service operations licensed under Ohio Revised Code Chapter 3717. This enables indirect/wholesale sales within Ohio. Products may not be sold outside the state of Ohio.

Varies. Huron County and City of Norwalk may have home occupation zoning requirements. Operators should verify with Huron County or their local zoning authority.

Pickup / delivery

Ohio allows direct and indirect sales within Ohio only. Farmers markets, retail stores, online (in-state), home pickup all permitted.

If you rent a commissary kitchen

ODA cottage food is not a food-service license. Ohio cottage food may be sold to licensed food-service operations. Baking in a commissary means that kitchen's food-service or food-establishment license applies. Local health departments license food service.
