Where to file

State

Ohio registration: No. Routine kitchen inspection: No. Labeled cottage food products may be sold to or used by retail food establishments and food service operations licensed under Ohio Revised Code Chapter 3717. This enables indirect/wholesale sales within Ohio. Products may not be sold outside the state of Ohio.

Zoning / home occupation

Conditional. Lake County and Painesville municipalities may require home occupation permits. Lake County is a suburban county east of Cleveland. Check with Lake County Planning Commission.

Health

No. No routine inspection; complaint-based enforcement

Business license

Pickup / delivery

Ohio-only sales allowed; direct to consumers. Farmers markets, events, home, online with Ohio delivery.

If you rent a commissary kitchen

ODA cottage food is not a food-service license. Ohio cottage food may be sold to licensed food-service operations. Baking in a commissary means that kitchen's food-service or food-establishment license applies. Local health departments license food service.
