Where to file

State

Ohio registration: No. Routine kitchen inspection: No. Labeled cottage food products may be sold to or used by retail food establishments and food service operations licensed under Ohio Revised Code Chapter 3717. This enables indirect/wholesale sales within Ohio. Products may not be sold outside the state of Ohio.

Zoning / home occupation

Conditional. Ohio state cottage food law does NOT preempt local ordinances. Montgomery County and City of Dayton may have home occupation permit requirements. Operators should contact Montgomery County Regional Planning or City of Dayton Planning for home occupation requirements.

Health

Conditional. Cottage Food: no inspection required. Ohio Home Bakery License: kitchen inspection required before license. ODA may sample for misbranding/adulteration.

Business license

Varies

Pickup / delivery

Direct from home, online, farmers markets, events, grocery stores, restaurants within Ohio. No interstate sales. No annual cap.

If you rent a commissary kitchen

ODA cottage food is not a food-service license. Ohio cottage food may be sold to licensed food-service operations. Baking in a commissary means that kitchen's food-service or food-establishment license applies. Local health departments license food service.
