Where to file

State

Ohio registration: No. Routine kitchen inspection: No. Labeled cottage food products may be sold to or used by retail food establishments and food service operations licensed under Ohio Revised Code Chapter 3717. This enables indirect/wholesale sales within Ohio. Products may not be sold outside the state of Ohio.

Zoning / home occupation

Conditional. Trumbull County unincorporated areas: home occupation rules enforced by individual townships. Municipalities (Warren, Niles, Girard, etc.) have their own zoning. Contact relevant township or municipal zoning office. Ohio cottage food URL for the county govt is co.trumbull.oh.us.

Health

No. No routine inspection under Ohio cottage food law. ODA may investigate upon complaint.

Business license

Varies

Pickup / delivery

Ohio cottage food law permits direct-to-consumer sales from home, events, farmers markets, and online. Products must stay within Ohio.

If you rent a commissary kitchen

ODA cottage food is not a food-service license. Ohio cottage food may be sold to licensed food-service operations. Baking in a commissary means that kitchen's food-service or food-establishment license applies. Local health departments license food service.
