Where to file

State

Oklahoma registration: No. Routine kitchen inspection: No. Sales are permitted on site, by delivery, at farmers markets, through cooperatives, and through membership-based buying clubs. The Oklahoma Department of Agriculture, Food, and Forestry may promulgate rules to allow sales at other locations or by other means. County ordinances may regulate but may not conflict with or impede the Act. For TCS foods, the producer must complete an approved food safety training (e.g., ServSafe Food Handler Training, max 8 hours, available online) before selling.

Varies. Grady County may have home occupation zoning provisions for home-based businesses. No specific county-level cottage food ordinance identified. Contact Grady County government in Chickasha.

No. Oklahoma OSDH may investigate upon complaint; no routine inspections.

Broad sales allowed including retail stores and online for non-TCS foods. TCS foods must be sold directly to informed end consumer.

If you rent a commissary kitchen

A commissary is a food-service license, not Food Freedom. Oklahoma Homemade Food Freedom is a home path. A commissary is a food establishment licensed by the State Department of Health.
