Where to file

State

Oklahoma registration: No. Routine kitchen inspection: No. Sales are permitted on site, by delivery, at farmers markets, through cooperatives, and through membership-based buying clubs. The Oklahoma Department of Agriculture, Food, and Forestry may promulgate rules to allow sales at other locations or by other means. County ordinances may regulate but may not conflict with or impede the Act. For TCS foods, the producer must complete an approved food safety training (e.g., ServSafe Food Handler Training, max 8 hours, available online) before selling.

Zoning / home occupation

Varies. Pittsburg County unincorporated areas generally not subject to county-wide zoning in Oklahoma. Incorporated areas (e.g., McAlester) have their own zoning and business license requirements. City of McAlester may have home occupation provisions in its zoning code. No county-specific cottage food zoning overlay identified. Producers must collect sales tax via OTC sales tax permit when selling at farmers markets.

Health

No. Investigation of reported foodborne illness only; no routine inspection

Business license

Varies

Pickup / delivery

Producer or producer's designated agent may deliver in-state only. Third-party delivery services not permitted for TCS foods.

If you rent a commissary kitchen

A commissary is a food-service license, not Food Freedom. Oklahoma Homemade Food Freedom is a home path. A commissary is a food establishment licensed by the State Department of Health.
