Where to file

State

Pennsylvania registration: Yes. Routine kitchen inspection: Yes. Registration includes sales direct from the production site including internet sales. However, a separate Retail Food Facility License may be required for sales at events or Farmers Markets. Businesses aiming to sell across state lines might also need FDA registration. The registration covers home-based operations in residential kitchens as well as residential-style kitchens in alternate locations such as churches, fire halls, or remodeled garages. Not available in Philadelphia County.

Zoning / home occupation

Conditional. PA LFE application packet (Section 2) explicitly requires producers to first contact their local municipality to verify zoning allows a food business at the proposed location. Cameron County has no county-wide zoning. Emporium Borough and rural townships have their own ordinances. Very small population county; limited municipal zoning activity.

Health

Yes. Initial on-site inspection required before registration is issued; subsequent routine inspections apply; assigned to PA Region 2 (Montoursville office)

Business license

Varies

Pickup / delivery

Direct sales and limited indirect sales allowed under LFE registration; online sales permitted; may need separate Retail Food Facility License for farmers market sales.

If you rent a commissary kitchen

PDA Limited Food Establishment is still not a retail commissary. Pennsylvania Limited Food Establishment covers certain residential-style kitchens. A retail commissary or shared kitchen typically needs a Retail Food Facility license as well. Ask PDA and the local health department.
