Where to file

State

Pennsylvania registration: Yes. Routine kitchen inspection: Yes. Registration includes sales direct from the production site including internet sales. However, a separate Retail Food Facility License may be required for sales at events or Farmers Markets. Businesses aiming to sell across state lines might also need FDA registration. The registration covers home-based operations in residential kitchens as well as residential-style kitchens in alternate locations such as churches, fire halls, or remodeled garages. Not available in Philadelphia County.

Zoning / home occupation

Varies. No state-level home occupation permit required beyond the PA Limited Food Establishment registration (\$35 for 2-year registration). Clearfield County may have local zoning home occupation requirements. No Clearfield County-specific cottage food ordinance found.

Health

Yes. Initial on-site kitchen inspection required before Limited Food Establishment registration is issued. Subsequent routine inspections apply.

Business license

Varies

Pickup / delivery

Direct and indirect sales permitted (to retail stores with specific requirements). Online sales allowed within Pennsylvania. Application must be submitted at least 60 days before operating.

If you rent a commissary kitchen

PDA Limited Food Establishment is still not a retail commissary. Pennsylvania Limited Food Establishment covers certain residential-style kitchens. A retail commissary or shared kitchen typically needs a Retail Food Facility license as well. Ask PDA and the local health department.
