Where to file

State

Pennsylvania registration: Yes. Routine kitchen inspection: Yes. Registration includes sales direct from the production site including internet sales. However, a separate Retail Food Facility License may be required for sales at events or Farmers Markets. Businesses aiming to sell across state lines might also need FDA registration. The registration covers home-based operations in residential kitchens as well as residential-style kitchens in alternate locations such as churches, fire halls, or remodeled garages. Not available in Philadelphia County.

Zoning / home occupation

Conditional. Montgomery County zoning governs home occupations in unincorporated areas. Most of Montgomery County is incorporated (Norristown, King of Prussia area, etc.) with their own home occupation permit rules. Contact the relevant municipality's planning department or Montgomery County Planning Commission for unincorporated areas.

Health

Yes. Initial on-site kitchen inspection required before registration. Subsequent routine inspections apply per state LFE regulations.

Business license

Varies

Pickup / delivery

Direct-to-consumer and limited indirect sales. Direct sales via home, markets, events, internet/online. Indirect retail sales permitted with LFE registration. Mail order possible for shelf-stable items. No wholesale-only without additional licensing.

If you rent a commissary kitchen

PDA Limited Food Establishment is still not a retail commissary. Pennsylvania Limited Food Establishment covers certain residential-style kitchens. A retail commissary or shared kitchen typically needs a Retail Food Facility license as well. Ask PDA and the local health department.
