Where to file

State

Pennsylvania registration: Yes. Routine kitchen inspection: Yes. Registration includes sales direct from the production site including internet sales. However, a separate Retail Food Facility License may be required for sales at events or Farmers Markets. Businesses aiming to sell across state lines might also need FDA registration. The registration covers home-based operations in residential kitchens as well as residential-style kitchens in alternate locations such as churches, fire halls, or remodeled garages. Not available in Philadelphia County.

Zoning / home occupation

Varies. No county-specific home occupation permit identified. Local municipalities in Northampton County (Easton, Bethlehem) may require home occupation zoning permits

Health

Yes. Initial inspection before license issuance; annual renewal

Business license

Varies

Pickup / delivery

Direct and limited indirect sales; farmers markets and retail allowed

If you rent a commissary kitchen

PDA Limited Food Establishment is still not a retail commissary. Pennsylvania Limited Food Establishment covers certain residential-style kitchens. A retail commissary or shared kitchen typically needs a Retail Food Facility license as well. Ask PDA and the local health department.
