Where to file

State

Pennsylvania registration: Yes. Routine kitchen inspection: Yes. Registration includes sales direct from the production site including internet sales. However, a separate Retail Food Facility License may be required for sales at events or Farmers Markets. Businesses aiming to sell across state lines might also need FDA registration. The registration covers home-based operations in residential kitchens as well as residential-style kitchens in alternate locations such as churches, fire halls, or remodeled garages. Not available in Philadelphia County.

Zoning / home occupation

Conditional. Venango County and its townships/municipalities may have home occupation zoning requirements. City of Franklin has its own zoning code. Recommend verifying with Venango County Planning Commission and relevant municipality.

Health

Yes. Initial on-site inspection required before registration issued. Subsequent routine inspections apply as part of LFE program.

Business license

Varies

Pickup / delivery

Direct-to-consumer and limited indirect sales allowed under LFE. Products may be sold at farmers markets, events, home, and to some retailers.

If you rent a commissary kitchen

PDA Limited Food Establishment is still not a retail commissary. Pennsylvania Limited Food Establishment covers certain residential-style kitchens. A retail commissary or shared kitchen typically needs a Retail Food Facility license as well. Ask PDA and the local health department.
