Where to file

State

Tennessee registration: No. Routine kitchen inspection: No. The Tennessee Food Freedom Act (Public Chapter 862, effective July 1, 2022) broadly exempts production and sale of non-TCS homemade food items from all licensing, permitting, inspecting, packaging, and labeling laws. Sales may be direct to consumer in person or remotely. Local government ordinances restricting homemade food sales are preempted. Note: Prior to the 2022 Food Freedom Act, the older domestic kitchen regulations (TDA Chapter 0080-4-11) required a permit, inspection, and food safety certification, and limited sales to 100 units/week; the Food Freedom Act supersedes these requirements for qualifying non-TCS homemade foods.

Zoning / home occupation

Varies. Madison County and the City of Jackson may have local home occupation zoning requirements. Tennessee state law does not preempt local zoning for home-based businesses; operators should verify with Madison County Planning or Jackson city zoning.

Health

No. DOH may investigate foodborne illness complaints but has no general inspection authority over cottage food under §53-1-125.

Business license

Varies

Pickup / delivery

Direct and indirect sales allowed under Tennessee Food Freedom Act. Online sales, home pickup, farmers markets, and events all permitted. No express prohibition on retail/wholesale for non-TCS foods.

If you rent a commissary kitchen

A commissary is a food-service permit. Food Freedom is not. Tennessee Food Freedom covers qualifying homemade non-TCS food. A commissary is a food service establishment permitted by the local health department.
