This is what it takes to sell from a home kitchen in Angelina County. Confirm each step with Planning, Health, and the license office before you sell.

HOW THIS PLACE WORKS

Texas does not let counties charge a cottage-food permit. State law says a local government may not require a permit, license, or fee for a cottage food production operation. The leftover local steps are usually city zoning, a DBA (assumed name) at the county clerk, and sales tax if your products are taxable. This packet shows the state DSHS page for the food rules.

Where to file

State

Texas registration: No. Routine kitchen inspection: No. Sales must be made directly to consumers or to a 'cottage food vendor' (a new category created by SB 541 in 2025 – a person with a contractual relationship who sells on behalf of the cottage food operation to consumers in-state). Cottage food products may not be sold as ingredients to a food service establishment. No retail grocery store or wholesale sales permitted under the pre-2025 framework; SB 541 (2025) adds the cottage food vendor intermediary option. Products must be delivered to consumer or vendor at point of sale or consumer-designated location.

Zoning / home occupation

Varies. Texas state law §559.955 (Home Business) may apply at local level. Angelina County and the City of Lufkin may have home occupation ordinances. No Angelina County-specific cottage food ordinance identified. Producers should check with Angelina County or City of Lufkin planning offices.

Health

No. Health departments may only act to prevent an immediate and serious threat to human life or health. No routine inspection authority.

Business license

Varies

Pickup / delivery

Direct sales from home, online, via mail, at farmers markets, and through indirect channels (to retailers who sell directly to consumers) are all permitted under Texas cottage food law. No wholesale to distributors.

If you rent a commissary kitchen

DSHS does not let locals permit cottage food. A commissary is different. Texas cottage food is exempt from food-establishment rules. A commissary, restaurant, or shared kitchen is a retail food establishment permitted by the local health department or DSHS.
