Where to file

State

Virginia registration: No. Routine kitchen inspection: No. As amended by HB 402 (Acts of Assembly 2026 Ch. 605), effective July 1, 2026: exempt foods may be sold at any location, through the internet, or by phone to an individual in Virginia for their own consumption, and delivered in person, by mail, or by delivery service in Virginia. Still no resale, consignment, restaurants, retail food establishments, or out-of-state sales. Local zoning still applies. The VDACS home-food-processor FAQ PDF is stale (still says no online sales); the statute controls. <https://lis.virginia.gov/bill-details/20261/HB402>

Varies. Campbell County is adjacent to Lynchburg and may have home occupation zoning requirements for home-based businesses. No specific Campbell County cottage food ordinance identified. Contact Campbell County government in Rustburg.

No. VDACS may inspect upon consumer complaint per Va. Code §3.2-5130(D).

Business license

Varies

Pickup / delivery

Direct sales only to end consumers. No consignment or retail store sales. Products must carry required label language.

If you rent a commissary kitchen

VDACS treats a commercial kitchen as a food-processing operation. Virginia cottage food is a home exemption. A commissary or commercial kitchen that manufactures food for sale needs a VDACS inspection and permit. VDACS publishes a commercial-kitchen food-processing application. Local health departments permit restaurants and similar food establishments.
