Pend Oreille County, Washington. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Washington registration: Yes. Routine kitchen inspection: Yes. Cottage food products may only be sold directly to the consumer. Internet sales, mail order, and retail sale outside Washington state are explicitly prohibited. Products may not be repackaged, sold, or used as an ingredient by a food processing plant, or sold by a food service establishment.

Zoning / home occupation

Conditional. Pend Oreille County is a heavily forested rural county in northeastern Washington on the Idaho border. Home-based businesses in unincorporated areas are subject to Pend Oreille County zoning code accessory use provisions. No county-specific cottage food overlay identified. Newport (county seat) has its own rules within city limits.

Health

Yes. Annual basic hygiene inspections required by Washington State Department of Agriculture as a permit condition. Permittee must sign document granting WSDA right of entry to home during normal business hours.

Business license

Varies

Pickup / delivery

Washington state cottage food law permits direct-to-consumer sales at farmers markets, events, and from home. Online sales and mail order outside Washington are restricted by statute. Home pickup generally allowed.

If you rent a commissary kitchen

Local health licenses food establishments. WSDA licenses cottage food. Washington cottage food is a WSDA permit for a home kitchen. A commissary is a food establishment permitted by the local health jurisdiction.
