Yakima County, Washington. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Washington registration: Yes. Routine kitchen inspection: Yes. Cottage food products may only be sold directly to the consumer. Internet sales, mail order, and retail sale outside Washington state are explicitly prohibited. Products may not be repackaged, sold, or used as an ingredient by a food processing plant, or sold by a food service establishment.

Zoning / home occupation

Conditional. Yakima County does not have county URL listed. Local zoning in Yakima County and City of Yakima may require home occupation permits. Check with Yakima County Planning Department.

Health

Yes. Annual basic hygiene inspection required; initial inspection before permit issued

Business license

Varies

Pickup / delivery

Direct sales only; no internet, mail order, or retail sales outside Washington State. Products may only be sold within Washington.

If you rent a commissary kitchen

Local health licenses food establishments. WSDA licenses cottage food. Washington cottage food is a WSDA permit for a home kitchen. A commissary is a food establishment permitted by the local health jurisdiction.
