Where to file

State

Wisconsin registration: No. Routine kitchen inspection: No. Home-canned goods must be sold at community or social events or farmers' markets in Wisconsin (§97.29(2)(b)2.b). The Kivirist court order applies to direct-to-consumer sales by home bakers. Products cannot be sold to retail food establishments or distributed through wholesale channels without a license.

Zoning / home occupation

Varies. Dodge County and its municipalities (Juneau, Beaver Dam, Waupun, etc.) each set their own home occupation rules. No Dodge County-specific cottage food permit requirement identified. Producers in municipalities should check with city/village planning offices. Beaver Dam and other Dodge County municipalities may have home occupation permit requirements for businesses generating customer traffic.

Health

No. DATCP does not conduct routine inspections for home bakers qualifying under Kivirist. Inspection may occur if complaint or foodborne illness is reported.

Business license

Varies

Pickup / delivery

Kivirist exception requires direct-to-consumer sales only. No wholesale. Home pickup and delivery to consumers is permitted under this framework. Pickle Bill exemption is limited to community events and farmers markets.

If you rent a commissary kitchen

DATCP licenses food processing; local health licenses restaurants. Wisconsin unlicensed home baking is a narrow path. A commissary is typically a DATCP food processing plant or a local food-service license. Ask the kitchen which license they hold.
