Where to file

State

Wisconsin registration: No. Routine kitchen inspection: No. Home-canned goods must be sold at community or social events or farmers' markets in Wisconsin (§97.29(2)(b)2.b). The Kivirist court order applies to direct-to-consumer sales by home bakers. Products cannot be sold to retail food establishments or distributed through wholesale channels without a license.

Zoning / home occupation

Varies. Jackson County follows standard Wisconsin local government zoning framework. Home occupation permits may be required under Jackson County zoning ordinance. No Jackson County-specific cottage food overlay identified. Black River Falls (county seat) has its own rules within city limits.

Health

No. DATCP has declined to enforce against qualifying home bakers per Kivirist injunction; complaint-driven action possible.

Business license

Varies

Pickup / delivery

Direct-to-consumer only for Kivirist-covered baked goods. Pickle Bill allows farmers market and community event sales only (up to \$5,000/year). No wholesale or retail sales allowed under either exception.

If you rent a commissary kitchen

DATCP licenses food processing; local health licenses restaurants. Wisconsin unlicensed home baking is a narrow path. A commissary is typically a DATCP food processing plant or a local food-service license. Ask the kitchen which license they hold.
