Where to file

State

Wisconsin registration: No. Routine kitchen inspection: No. Home-canned goods must be sold at community or social events or farmers' markets in Wisconsin (§97.29(2)(b)2.b). The Kivirist court order applies to direct-to-consumer sales by home bakers. Products cannot be sold to retail food establishments or distributed through wholesale channels without a license.

Zoning / home occupation

Varies. Shawano County is in northeast Wisconsin and includes portions of the Menominee Indian Reservation adjacent to the county. Local zoning is administered at the town level; home occupation permit requirements vary by individual town ordinance. Shawano County has a farmland preservation zoning program. No county-specific cottage food overlay identified.

Health

No. DATCP has declined to enforce against home bakers per Kivirist injunction; complaint-driven action possible.

Business license

Varies

Pickup / delivery

Direct-to-consumer only for Kivirist-covered baked goods. Pickle Bill allows farmers market/community event sales only. No wholesale, retail, or online resale.

If you rent a commissary kitchen

DATCP licenses food processing; local health licenses restaurants. Wisconsin unlicensed home baking is a narrow path. A commissary is typically a DATCP food processing plant or a local food-service license. Ask the kitchen which license they hold.
